The Plan and scheme were referred to in G.N. 7389 published on 24 December 2014 and 2 January 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 25 July 2016, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be permanently closed, shall be extinguished; and from 25 July 2016 to 24 July 2017, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve extension of the existing car park at the western side of New Territories Heung Yee Kuk Southern District Secondary School and construction of sections of carriageways and footpaths; as well as ancillary works
