Under section 15(1) and section 15(2) of the Ordinance, with effect from the publication in the *Gazette* of the aforesaid notice, the owner of each relevant interest shall be liable to pay the annual Government rent as so determined from 25 June 2009 and the annual instalment of premium as so determined from 26 December 2013.
