

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 1264EM15T—36-Month Term Contract for Building Services and Fitting-out Works to Health Sector Venues in Kowloon Central Region**. The scope of works consists of fitting-out, replacement, alterations, additions and improvement to various building services installations and associated builder's works for the health sector venues in Kowloon Central Region. The contract period is 36 months and the contract is scheduled to commence in December 2016.
