

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. 2646EM15T—Triennial Term Contract for Maintenance of Domestic Electrical Appliances, Electrical Installations and Floodlight Installations at Various Venues of Transport, Security and Central Services Division**. The scope of works includes the corrective maintenance and replacement services of electrical installations, floodlight installations and domestic electrical appliances for the quarters of the Hong Kong Police Force, the Independent Commission Against Corruption and the Correctional Services Department and the venues of the Customs and Excise Department, the Fire Services Department and the Immigration Department. The contract period is 36 months and the contract is scheduled to commence in December 2016.
