SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF PART OF SUNG WONG TOI PLAYGROUND;
SECTIONS OF MA TAU CHUNG ROAD AND ARGYLE STREET, AND
THE PEDESTRIAN SUBWAYS CONNECTING OLYMPIC GARDEN AND
MA TAU CHUNG ROAD, CONNECTING OLYMPIC GARDEN AND
THE JUNCTION OF ARGYLE STREET AND PRINCE EDWARD ROAD WEST,
AND CONNECTING OLYMPIC GARDEN AND
THE JUNCTION OF ARGYLE STREET AND MA TAU CHUNG ROAD; AND
TEMPORARY ALTERATION OF A SECTION OF MA TAU CHUNG ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 5 August 2016 (the 'Order'), authorized:—

- (I) the temporary closure of part of Sung Wong Toi Playground, as delineated and shown in red on the Plans numbered SCL/G19/0024/4 and SCL/G22/0024/4 during the period from 27 August 2016 to 26 August 2017;
- (II)
 - (a) the temporary partial closure of the section of Ma Tau Chung Road between its junction with Argyle Street and a point about 100 metres southwest of the roundabout at Olympic Garden, and the section of Argyle Street between the roundabout at Olympic Garden and a point about 80 metres southwest of the roundabout, as delineated and shown in yellow and dark green respectively on the Plans numbered SCL/G19/0024/4 and SCL/G22/0024/4;
 - (b) the temporary partial closure of the pedestrian subway connecting Olympic Garden and Ma Tau Chung Road, as delineated and shown in orange on the Plan numbered SCL/G19/0024/4; and
 - (c) the temporary alteration of the section of Ma Tau Chung Road between a point about 90 metres northeast and a point about 90 metres southwest of the roundabout at Olympic Garden, as delineated and shown in dark blue on the Plans numbered SCL/G19/0024/4 and SCL/G22/0024/4,
during the period from 27 September 2016 to 26 September 2017; and
- (III)
 - (a) the temporary closure of the pedestrian subway connecting Olympic Garden and the junction of Argyle Street and Prince Edward Road West, as delineated and shown in blue on the Plans numbered SCL/G19/0024/4 and SCL/G22/0024/4; and

- (b) the temporary partial closure of the pedestrian subway connecting Olympic Garden and the junction of Argyle Street and Ma Tau Chung Road, as delineated and shown in pink on the Plans numbered SCL/G19/0024/4 and SCL/G22/0024/4,

during the period from 1 October 2016 to 28 February 2017,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the area of Sung Wong Toi Playground, the sections of the roads and the pedestrian subways to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plans numbered SCL/G19/0024/4 and SCL/G22/0024/4 (the 'Plans') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

A copy of this notice will be affixed on or near Sung Wong Toi Playground, the roads and the pedestrian subways affected by the Order on 12 August 2016.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure/alteration of the relevant part or parts of Sung Wong Toi Playground, the roads and the pedestrian subways or the extinction, modification or restriction of his private right in respect of the relevant part or parts of Sung Wong Toi Playground, the roads and the pedestrian subways affected by the Order.

Notice is hereby given that further closure/alteration of the same part or parts of Sung Wong Toi Playground, the roads and the pedestrian subways or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure/alteration will be published if and when such an order is made.
