

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
(Notice under section 18)

PROPOSED CYCLE TRACK AT CHE KUNG MIU ROAD
BETWEEN MEI TIN ROAD AND HIN KENG STREET, SHA TIN

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing footpaths, lay-by and roadside amenities; and temporarily sections of the existing carriageways, footpaths, vehicular run-ins/run-outs and roadside amenities within the limit of works area as shown on Plans Nos. HWDST082A-GZ0001 and HWDST082A-GZ0002 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plan No. HWDST082A-GZ0003 ('the Amendment Plan') and described in the amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 3648 published on 27 June 2014 and 4 July 2014. The Amendment Plan and amendment scheme were referred to in G.N. 3521 published on 22 May 2015 and 29 May 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 13 August 2016, all public or private rights in, upon, under or over the sections of the existing footpaths, lay-by and roadside amenities to be permanently closed, shall be extinguished; and from 13 August 2016 to 12 August 2017, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, vehicular run-ins/run-outs and roadside amenities to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve construction of sections of a two-way cycle track with footpaths along Che Kung Miu Road between Tin Sam Street and Hin Keng Street, and other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths, lay-by, roadside amenities and vehicular run-ins/run-outs on 12 August 2016.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written claims served under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) will be used for the processing of the claims and other related purposes. The provision of the information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is obligatory. If such information, including the personal data, as required under section 29 of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is not provided as requested, the claims may be rejected. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other organizations or agencies which are required to handle the claims and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
