

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. KL/2016/02 Demolition and Ground Decontamination Works for Development at North West Kowloon Reclamation Site 1, Sham Shui Po—Phase 1**. The works include demolition of the existing buildings and structures of the ex-Cheung Sha Wan Abattoir and ground decontamination works for remediation of contaminated soil. The works are scheduled to commence in the fourth quarter of 2016 and will take about 12 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the tender box located in Room 4128f on the 41st Floor, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 23 September 2016. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 23 September 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.
