

It is hereby notified that sealed tenders in duplicate are invited for **nominated sub-contract to Contract No. SS E507—Building Services Installation for the Construction of Columbarium at Wo Hop Shek Cemetery—Phase 1 (Programme No. 22NB)**.

The works of the nominated sub-contract include design, supply, installation, testing and commissioning of building services installation comprising electrical installation, air conditioning and mechanical ventilation installation, fire service installation, low voltage cubicle switchboard installation and plumbing installation for the Construction of Columbarium at Wo Hop Shek Cemetery—Phase 1. The main contract is scheduled to commence in December 2016 and for completion in May 2019.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 4128f on the 41st Floor of the Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 30 September 2016. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in force at any time between 9.00 a.m. and 12.00 noon on Friday, 30 September 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 has been replaced by a lower signal.

Contractors not yet on the above-mentioned approved list/category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 13 September 2016 to Chief Quantity Surveyor/3 of Architectural Services Department at 34th Floor, Queensway Government Offices, 66 Queensway, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. The successful tenderer will be required to enter into a Sub-contract with the Main Contractor. Tenderers are reminded that the Government of the Hong Kong Special Administrative Region is not bound to nominate for acceptance any tender irrespective of whether the tender is the lowest bid or, where the assessment of the tenders is based on a marking scheme or formula approach, the tender with the highest overall score.
