- 4. You are required to commence the works ordered by me in paragraph 3 above within $\underline{30}$ days and complete such works within $\underline{60}$ days of the date of this order, all to the satisfaction of the Building Authority.
- 5. Section 46 of the Interpretation and General Clauses Ordinance (Cap. 1) provides, inter alia, that where any Ordinance confers power upon any person to make any order, such power shall include power to substitute another order for the one already made. Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. C/M2/002330/14/K dated 3 September 2014 is empowered to make this order which substitutes the previous order.
