It has been brought to my attention that the following building works have been carried out in or at the above premises:

- (i) Two Metal gates erected across the common corridor obstructing the means of escape.
2. For the said building works:
- (a) As a result of the building works at items (i) above, Regulation 41(1) of the Building (Planning) Regulations, which requires the building to be provided with such means of escape in case of emergency as required by the intended use of the building, has been contravened.
3. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-
- (a) Demolish the said building works described under items (i) and (ii) above; and
 - (b) Reinststate the parts of the building so affected by the building works under items (i) above in accordance with the *plans approved by the Building Authority/ minor works completion record submitted to the Building Authority.

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

4. You are required to commence the works ordered by me in paragraph 3 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.

5. Section 46 of the Interpretation and General Clauses Ordinance (Cap. 1) provides, inter alia, that where any Ordinance confers power upon any person to make any order, such power shall include power to substitute another order for the one already made. Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. C/M2/002330/14/K dated 3 September 2014 is empowered to make this order which substitutes the previous order.
