# 醫生註冊條例 (第161章) MEDICAL REGISTRATION ORDINANCE (Chapter 161)

現依據《醫生註冊條例》第15(2)條,將2016年1月1日至2016年7月1日期間以「有限度註冊」列於普通科醫生名冊第 III 部,即有資格在本港的指定機構及在有效註冊期間執行內外全科醫生業務的人士的名單刊載如下:

刊載列於普通科醫生名冊人士的名單,是要讓市民知道根據《醫生註冊條例》的規定,名單上所有人士均有資格在本港執行內外全科醫生業務。任何人如濫用名單上的個人資料作與此無關的用途,均須負上循《個人資料(私隱)條例》(第486章)而被追究的責任。

Pursuant to section 15(2) of the Medical Registration Ordinance, the following list of persons whose names were added to Part III of the General Register between the 1st day of January 2016 and the 1st day of July 2016 with 'limited registration' and qualified to practise medicine and surgery in specified employment in Hong Kong and within the specified period, is published:—

The purpose of publishing a list of persons whose names appear in the General Register is to inform the public that each person named in the list is qualified to practise medicine and surgery in Hong Kong under the Medical Registration Ordinance. Persons using the personal data therein for an unrelated purpose render themselves liable to action under the Personal Data (Privacy) Ordinance, Chapter 486.

## 附註:

按《醫生註冊條例》(第161章)的規定,凡執行醫務人士均須持有是年有效的執業證明書方可在本港執業。然而此規定並不嫡用於:

- (甲) 任何根據第12條獲臨時註冊的人士;
- (乙) 任何憑藉第29(a) 或(b) 條當作已註冊為醫生的人士;
- (丙) 行政長官根據第30條給予同意的人士;
- (丁) 任何與第31條有關的人士;或
- (戊) 任何符合資格的人士,但以他是在緊急情況下向任何人士提供內科或外科治療為限。

### Note:-

No medical practitioner is entitled to practise in Hong Kong unless he is in possession of a valid practising certificate for the current year in accordance with the provisions of the Medical Registration Ordinance (Chapter 161). This does not apply to:—

- (a) any person provisionally registered under section 12;
- (b) any person deemed to be registered as a medical practitioner by virtue of section 29(a) or (b);
- (c) any person in respect of whom the Chief Executive has given consent under section 30;
- (d) any person to whom section 31 relates; or
- (e) any qualified person in so far as he renders medical or surgical treatment to a person in an emergency.
