

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. CV/2016/08—Queen's Hill Development—Sewage Pumping Station Works**. The works include construction of a sewage pumping station, and ancillary works including drainage, waterworks and landscaping works. The works are scheduled to commence in November 2016 and will take about 45 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 21 October 2016. Late tenders will not be accepted.

If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 21 October 2016, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of the change will be made through the radio.

Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the lead participant/major shareholder in case of a joint venture tenderer, has completed at least one (1) road and drainage works contract involving construction of sewage pumping station(s) with awarded contract sum of not less than HK\$80 million, in or outside Hong Kong, within the past 10 years.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 5 October 2016 to Principal Project Coordinator/Housing Projects 1, Civil Engineering Office, Civil Engineering and Development Department at 3rd Floor, Civil Engineering and Development Building, 101 Princess Margaret Road, Ho Man Tin, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
