The scope of works for this contract includes operation, maintenance, additions, alterations and improvement works of air-conditioning installations for the venues of Hong Kong Police Force, Independent Commission Against Corruption and Security Bureau in Hong Kong Island and Outlying Islands. The Works are scheduled to commence on 1 February 2017 and complete on 31 January 2020.
