COUNTRY PARKS ORDINANCE (Chapter 208)

(Section 9(1))

In accordance with sections 8 and 15(1) of the Country Parks Ordinance (the Ordinance), the Country and Marine Parks Authority has prepared the following:—

- (i) a draft map (Plan No. CP/PC^C) and explanatory statement to replace the approved map (Plan No. CP/ PCB) of the Plover Cove Country Park; and
- (ii) a draft map (Plan No. CP/LT(S)^B) and explanatory statement to replace the approved map (Plan No. CP/LT(S)A) of the Lantau South Country Park.

Draft Map (Plan No. CP/PC^C) of the Plover Cove Country Park

The new boundary of the Plover Cove Country Park and two proposed areas to be incorporated into the Plover Cove Country Park are shown in the draft map. The two proposed areas are located at Fan Kei Tok, north of Wu Kau Tang and at Sai Lau Kong next to Ngau Shi Wu Wan, with areas of about 4.6 hectares and 1.9 hectares respectively. The total area of the Plover Cove Country Park covered by the draft map, after the incorporation of the two proposed areas, is about 4.600 hectares.

Draft map (Plan No. $CP/LT(S)^B$) of the Lantau South Country Park

The new boundary of the Lantau South Country Park and a proposed area to be incorporated into the Lantau South Country Park are shown in the draft map. The proposed area is located near Nam Shan, east of Yi Tung Shan, with an area of about 5.9 hectares. The total area of the Lantau South Country Park covered by the draft map, after the incorporation of the proposed area, is about 5 646 hectares.

Such written statement shall set out:—

- (a) the nature of and reasons for the objection; and
- (b) if the objection would be removed by an alteration to the draft map, any alteration proposed.
