WHEREAS the Building Authority acting in accordance with the powers conferred upon him by section 27A of the Buildings Ordinance has served on the owner of the above-mentioned lot an order in writing dated the 29th day of August 2006 declaring the natural, formed or man-made land on the above lot to be liable to become dangerous and requiring such owner to carry out the works within the time limit specified therein

AND WHEREAS the said order has not been complied with

AND WHEREAS the Building Authority acting in accordance with the powers conferred upon him by section 27A(3) of the said Ordinance has caused the said works to be carried out during the period from the 5th day of February 2013 to the 27th day of May 2014 by the Government Consultant/Contractor


AND WHEREAS the cost of the said works and surcharge are in my opinion recoverable from the owner of the said lot

AND WHEREAS it appears from Land Registry records that the above-mentioned lot was as at the date of completion of the said works owned by the Owner of Tai Po New Territories (Lot No. 99 in D.D. 8)

AND WHEREAS the owner of the said lot was advised of the said works in writing on the 30th day of April 2015

NOW THEREFORE in accordance with the provisions of section 33(1) of the Buildings Ordinance I HEREBY CERTIFY that the cost of the works so caused by the Building Authority to be carried out and surcharge as aforesaid amounts to Hong Kong Dollars One Hundred Fifty-five Thousand Nine Hundred Sixty-four and Cents Forty only (HK\$155,964.40) and that the said Owner of Tai Po, New Territories (Lot No. 99 in D.D. 8) is liable for that sum
