TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently a section of the existing at grade footpath and the existing ramps; and temporarily sections of the existing carriageways, at grade footpaths, bridge decks and ramps within the limit of works area as shown on Plan No. CE58/GAZ/KF76/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 9051 published on 27 November 2015 and 4 December 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 19 November 2016, all public or private rights in, upon, under or over the section of the existing at grade footpath and the existing ramps to be permanently closed, shall be extinguished; and from 19 November 2016 to 18 November 2017, all public or private rights in, upon, under or over the sections of the existing carriageways, at grade footpaths, bridge decks and ramps to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of two lifts at the existing footbridge No. KF76 across Fung Tak Road near Lung Poon Street, the construction of elevated platforms to connect the proposed lifts with the existing footbridge and other ancillary works.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.
