TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently an existing ramp; and temporarily sections of the existing carriageways and footpaths within the limit of works area as shown on Plan No. CE58/GAZ/KF106/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 4529 published on 8 August 2014 and 15 August 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 26 November 2016, all public or private rights in, upon, under or over the existing ramp to be permanently closed, shall be extinguished; and from 26 November 2016 to 25 November 2017, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a lift at the existing footbridge No. KF106 across Hung Hom South Road near Hung Hom Road, the construction of an elevated platform to connect the proposed lift with the existing footbridge and other ancillary works.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.
