Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. UBZ/U18-02/0011/09 dated 29September2010 is also empowered to make this order which substitutes the previous order.
