

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

ROAD IMPROVEMENT WORKS AT MA ON SHAN, SHA TIN

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. ST49/GAZ/C/DSB-01 ('the Plan') and described in the scheme annexed thereto, which the Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) realignment of a section of the existing Hang Tai Road;
- (ii) construction of a slip road connecting the existing Hang Tai Road to the existing Ma On Shan Road (northbound);
- (iii) widening of a section of the existing Ma On Shan Road (southbound) for providing vehicular ingress to/egress from the proposed public housing development at Ma On Shan Road;
- (iv) realignment of a section of the existing Sai Sha Road;
- (v) modification of the existing junction at Hang Shun Street/Hang Tak Street/A Kung Kok Street;
- (vi) construction of carriageways, footpaths, planters, amenity area, traffic islands, taxi stand, and vehicular run-in/run-out;
- (vii) permanent closure and conversion of sections of the existing carriageways into footpaths, planters, amenity areas and traffic islands;
- (viii) permanent closure and conversion of sections of the existing footpaths into carriageways, planters, cycle parking place, bus stops and taxi stand;
- (ix) permanent closure and conversion of sections of the existing planters into carriageways, footpaths, traffic island, cycle parking place and taxi stand;
- (x) permanent closure and conversion of sections of the existing amenity areas into carriageways, footpaths, planters and bus stop;
- (xi) permanent closure and conversion of sections of the existing traffic islands into carriageways and planter;
- (xii) permanent closure and conversion of a section of the existing bus stop into footpath;
- (xiii) permanent closure and conversion of sections of the existing slope into carriageway and amenity area;
- (xiv) permanent closure and conversion of a section of the existing cycling track into cycle parking place;
- (xv) permanent closure and conversion of a section of the existing cycle parking place into footpath;
- (xvi) permanent closure and demolition of sections of the existing carriageways, footpaths, planters and cycle parking place;
- (xvii) temporary closure and reconstruction of sections of the existing carriageways, footpaths, planters, amenity areas, bus stops and cycle parking place;
- (xviii) temporary closure of sections of the existing carriageways, footpaths, planters, amenity areas, traffic islands, bus stops, slope, cycling tracks and cycle parking place; and
- (xix) ancillary works including civil engineering, geotechnical, drainage, sewerage, water supply, utility and landscaping works and construction of noise barrier, street lighting and street furniture.

The Plan and scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person who wishes to object to the works or the use, or both, is required to address his objection in writing to the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the office of the Secretary not later than the 17th day of January 2017, describing his interest and the manner in which he alleges that he will be affected by the works or the use. Objectors are requested to provide contact details to the Secretary to facilitate communication.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Housing Bureau (Transport Branch) at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
