WORKS AT KWU TUNG NORTH NEW DEVELOPMENT AREA AND  
FANLING NORTH NEW DEVELOPMENT AREA (ROAD WORKS)

*Amendments under section 7*

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Housing (Transport) proposes to amend the works originally shown on Plans Nos. 60335576/GZ1/100 to 60335576/GZ1/114 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 10021 published under section 8(2) of the Ordinance on 31 December 2015 and 8 January 2016.

The proposed amendments are shown on Amendment Plans Nos. 60335576/GZ1/100A, 60335576/GZ1/LEGEND, 60335576/GZ1/102A, 60335576/GZ1/102A, 60335576/GZ1/103A, 60335576/GZ1/104A, 60335576/GZ1/105A, 60335576/GZ1/108A, 60335576/GZ1/109A, 60335576/GZ1/110A, 60335576/GZ1/111A, 60335576/GZ1/112A, 60335576/GZ1/113A and 60335576/GZ1/115 ('the Amendment Plans') and described in the amendment scheme annexed thereto, which the Amendment Plans and amendment scheme have been deposited in the Land Registry.

The general nature and extent of the proposed amendments are as follows:—

- (a) Amendment A at Road D4 in Kwu Tung North (KTN) New Development Area (NDA) (as shown on Amendment Plan No. 60335576/GZ1/102A):—
  - (i) deletion of the originally proposed vertical noise barrier.
- (b) Amendment B at Road D4 in KTN NDA (as shown on Amendment Plan No. 60335576/GZ1/102A):—
  - (i) deletion of sections of the originally proposed at grade footpath;
  - (ii) revision of the originally proposed limit of works area; and
  - (iii) construction of run-ins.
- (c) Amendment C at Road D4 in KTN NDA (as shown on Amendment Plan No. 60335576/GZ1/103A):—
  - (i) deletion of the originally proposed cantilever noise barrier and sections of the originally proposed at grade footpaths; and
  - (ii) construction of run-ins.
- (d) Amendment D at Road D3 and Road D4 in KTN NDA (as shown on Amendment Plan No. 60335576/GZ1/103A):—
  - (i) deletion of the originally proposed cantilever noise barriers and full enclosure noise barrier;
  - (ii) deletion of sections of the originally proposed vertical noise barriers and amenity area;
  - (iii) revision of sections of the originally proposed at grade carriageway and at grade footpath;
  - (iv) revision of the originally proposed limit of works area; and
  - (v) construction of vertical noise barriers.
- (e) Amendment E at Road P1 in KTN NDA (as shown on Amendment Plan No. 60335576/GZ1/104A):—
  - (i) deletion of sections of the originally proposed vertical noise barriers.
- (f) Amendment F at Road D1, Road L1 and the footpath/access near Po Lau Road in KTN NDA (as shown on Amendment Plan No. 60335576/GZ1/105A):—

- (i) deletion of the originally proposed at grade footpaths, cycle tracks vertical noise barriers and cantilever noise barriers and sections of the originally proposed at grade footpaths, cycle track and amenity area;
  - (ii) revision of the originally proposed run-in and a section of the originally proposed at grade carriageway;
  - (iii) revision of the originally proposed permanent closure and demolition of a section of the existing at grade footpath/access;
  - (iv) revision of the originally proposed temporary closure of a section of the existing at grade footpath/access;
  - (v) revision of the originally proposed limit of works area;
  - (vi) construction of at grade carriageways, at grade footpaths, cycle tracks, reprovisioned accesses, pedestrian crossings and cantilever noise barrier; and
  - (vii) permanent closure and demolition of a section of the existing at grade footpath/access.
- (g) Amendment G at Road L1 and Road L2 in Fanling North (FLN) NDA, Ma Sik Road and Fan Leng Lau Road (as shown on Amendment Plan No. 60335576/GZ1/108A):—
- (i) deletion of sections of the originally proposed at grade carriageways, at grade footpaths, amenity areas and slopes;
  - (ii) deletion of the originally proposed run-ins, cycle track, staircases, central reserves/refuge islands, reprovisioned accesses, cantilever noise barriers, vertical noise barrier, retaining wall and pedestrian crossings;
  - (iii) deletion of the originally proposed permanent closure and demolition of sections of the existing at grade footpaths/accesses, central reserves/refuge islands, and amenity areas;
  - (iv) deletion of the originally proposed temporary closure of the existing at grade carriageways, at grade footpaths/accesses, central reserves/refuge islands and amenity areas;
  - (v) revision of the originally proposed limit of works area; and
  - (vi) construction of at grade footpaths, amenity area, slopes and staircase.
- (h) Amendment H at Road L1 and Road L2 in FLN NDA (as shown on Amendment Plans Nos. 60335576/GZ1/ 108A and 109A):—
- (i) deletion of sections of originally proposed at grade carriageway, at grade footpaths and amenity area;
  - (ii) deletion of the originally proposed temporary closure of a section of the existing at grade footpath/access;
  - (iii) revision of the originally proposed run-in;
  - (iv) revision of the originally proposed limit of works area;
  - (v) construction of at grade carriageways, at grade footpaths and pedestrian crossings; and
  - (vi) temporary closure of a section of the existing at grade footpath/access.
- (i) Amendment I at Lung Yeuk Tau Interchange, Sha Tau Kok Road-Lung Yeuk Tau, Ma Sik Road, On Kui Street, On Lok Mun Street, Fanling Bypass Eastern Section and Ma Wat River (as shown on Amendment Plans Nos. 60335576/GZ1/109A, 110A and 115):—
- (i) deletion of the originally proposed cycle tracks, footbridges, lifts, vertical noise barriers, cantilever noise barriers and pedestrian crossings;
  - (ii) deletion of sections of the originally proposed at grade footpaths, cycle track, amenity areas and staircases;
  - (iii) deletion of the originally proposed permanent closure and demolition of sections of the existing at grade carriageways, at grade footpaths/accesses, footbridges and amenity area;
  - (iv) deletion of the originally proposed temporary closure of sections of the existing at grade carriageways and at grade footpath/access;
  - (v) deletion of the originally proposed permanent closure and demolition of a section of the existing Ma Wat River channel (including its drainage inlet);
  - (vi) deletion of the originally proposed reconstruction of a section of the existing Ma Wat River channel (including its drainage inlet);

- (vii) revision of sections of the originally proposed at grade carriageway, underpass, elevated carriageways, central reserves/refuge islands, cycle track cum footbridge and footbridge;
  - (viii) revision of the originally proposed limit of works area;
  - (ix) construction of run-ins, at grade carriageways, at grade footpaths, cycle tracks, cycle track cum footbridge, amenity areas, central reserve/refuge island, semi-enclosure noise barriers, cantilever noise barriers and pedestrian crossings;
  - (x) permanent closure and demolition of sections of the existing at grade carriageways, at grade footpaths/accesses, cycle tracks and amenity areas; and
  - (xi) temporary closure of sections of the existing at grade carriageways, at grade footpaths/accesses, cycle track, amenity areas and central reserve/refuge island.
- (j) Amendment J at Fanling Bypass Eastern Section (as shown on Amendment Plan No. 60335576/GZ1/111A):—
- (i) revision of the originally proposed vertical noise barrier and sections of the originally proposed elevated carriageway and central reserve/refuge island; and

- (k) Amendment K at Fanling Bypass Eastern Section (as shown on Amendment Plan No. 60335576/GZ1/112A):—
- (i) revision of sections of the originally proposed elevated carriageways; and
  - (ii) revision of the originally proposed limit of works area.
- (l) Amendment L at Fanling Bypass Eastern Section and Tai Wo Service Road West (as shown on Amendment Plans Nos. 60335576/GZ1/112A and 113A):—
- (i) deletion of the originally proposed vertical noise barrier and amenity areas;
  - (ii) deletion of the originally proposed permanent closure and demolition of sections of the existing at grade carriageway;
  - (iii) revision of sections of the originally proposed at grade carriageway, at grade footpaths, cycle track, amenity area, pedestrian crossings and central reserves/refuge islands;
  - (iv) revision of the originally proposed permanent closure and demolition of a section of the existing at grade footpath/access;
  - (v) revision of the originally proposed limit of works area;
  - (vi) construction of amenity area, cantilever noise barriers and retaining wall; and

  - (iv) revision of the originally proposed limit of works area;

  - (vi) permanent closure and demolition of sections of the existing at grade footpaths/accesses.
