### (SEWERAGE WORKS)

Notice is hereby given that the Director of Environmental Protection proposes to amend the sewerage works originally described in the scheme and the Plans Nos. 60335576/GZ3/400—410 and Resumption Plan No. DNM5015 (Sheets 1 to 6) (the 'Plans') referred to in G.N. 10023 published under section 8(2) of the Roads (Works, Use and Compensation) Ordinance as applied by section 26 of the Water Pollution Control (Sewerage) Regulation on 31 December 2015 and 8 January 2016.

Take further notice that the Director of Environmental Protection proposes to execute the amendment sewerage works as shown on the Amendment Plans Nos. 60335576/GZ3/400A, 60335576/GZ3/408A, 60335576/GZ3/409A and 60335576/GZ3/410A and Amendment Resumption Plan No. DNM5015a (Sheets 1 to 6) (the 'Amendment Plans') and described in the amendment scheme annexed thereto, which the Amendment Plans and the amendment scheme have been deposited in the Land Registry.

The general nature of the proposed amendments is as follows:—

- (i) revisions of the originally proposed limit of works area as shown on the Amendment Plans;
- (ii) deletion of sections of originally proposed rising mains, gravity sewers and associated manholes as shown on the Amendment Plans;
- (iii) addition of proposed rising mains, gravity sewers, associated manholes and a proposed sewage pumping station as shown on the Amendment Plans;
- (iv) deletion of originally proposed existing carriageways to be temporarily closed as shown on the Amendment Plans;
- (v) addition of existing carriageways to be temporarily closed as shown on the Amendment Plans;
- (vi) addition of existing carriageways to be permanently closed and demolished as shown on the Amendment Plans;
- (vii) deletion of the originally proposed resumption of former Lot No. 394 S.D (Portion) and former Lot No. 692 S.C RP both in D.D.95;
- (viii) revision of the area of land in the originally proposed resumption of Lot No. 719 RP (Portion) in D.D.95 as shown on the Amendment Plans; and
- (ix) addition of newly proposed resumption of Lots Nos. 1347 S.A (Portion), 1347 S.B (Portion), 1348 S.B RP (Portion), 1349 (Portion), 1351 RP (Portion) all in D.D.83 as shown on the Amendment Plans.

Any information, including the personal data, so submitted may be disclosed to the related government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters.
