# NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF KIANG SU STREET AND LOK SHAN ROAD

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 15 November 2016 (the 'Order'), authorized:—

- (I) the temporary closure of the section of Kiang Su Street between Ma Tau Wai Road and Maidstone Road, as delineated and shown in light pink on the Plan numbered SCL/G24/0055/2; and
- (II) the temporary partial closure of the section of Lok Shan Road between Ma Tau Wai Road and Maidstone Road, as delineated and shown in dark brown on the Plan numbered SCL/G24/0055/2.

during the period from 18 December 2016 to 8 July 2017 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
