

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

 SITE FORMATION AND INFRASTRUCTURE WORKS FOR DEVELOPMENT  
 AT KAM TIN SOUTH, YUEN LONG)

Notice is hereby given that under section 11(2)(b) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Chief Executive in Council has authorized the works and the use as described in G.N. 1641 published on 24 March 2016 and 1 April 2016 with modifications, including modification to land resumption, as shown on Modification Plans Nos. 60336159/GAZ1/101A(INSET A) and 60336159/GAZ1/104A(INSET A) ('the Modification Plans') and Resumption Plan No. YLM9121a (Sheet 1 of 3 to Sheet 3 of 3) ('the Resumption Plan') and described hereunder. The Modification Plans and the Resumption Plan have been deposited in the Land Registry.

The modifications are as follows:—

- (i) revision of the proposed junction modification at Kam Tin Road/Kam Sheung Road and the associated limit of works area;
- (ii) revision of a proposed bus layby along Kam Sheung Road and the associated limit of works area; and
- (iii) revision of the resumption/clearance limit in relation to modifications as described in (i) and (ii) above, including exclusion of Lot Nos. 294 RP (Portion) and 295 RP (Portion) in D.D.109 from the resumption limit.
