 (a) submit remedial proposals to the Building Authority for approval and obtain consent for commencement of works before
 - commencing such works; and
 - (b) on completion, certify that such works have been carried out in accordance with the provisions of the Buildings Ordinance and regulations made thereunder
- You are required to commence the works ordered by me in paragraph 3 above within 90 days and complete such works within 180 days of the date of this order, all to the satisfaction of the Building Authority.






