It has been brought to my attention that the following building works have been carried out in or at the above premises:

- (i) A Structure on and over the garden on LG/F at the rear of the premises;
 - (ii) A structure on and over the court on G/F of the premises;
 - (iii) A structure erected on the G/F and part of the structure erected on item(i) at the rear of the premises;
 - (iv) A structure on and over the flat roof on 1/F at the rear of the premises;
 - (v) Glass Parapet(s) erected at the planter on R/F at the front of the premises;
 - (vi) Removal of approved metal railing on R/F at the front of the premises;
 - (vii) A structure on and over the R/F at the front of the premises;
 - (viii) A structure erected on the R/F and part of the structure erected on item(iv) at the rear of the premises; and
 - (ix) Removal of approved metal railing on R/F at the rear of the premises and partly replaced by glass parapet.
- (The locations of the building works described above are shown hatched-black on the plan annexed hereto, for the purpose of identification only.)*

2. For the said building works:
 - (a) The building works at Item (i) to (ix) above has been carried out without having first obtained from me the approval of building plans and consent for the commencement of such building works required by section 14 of the Buildings Ordinance.
3. In exercise of the powers vested in me under section 24(1) of the Buildings Ordinance, I hereby order you to :-
 - (a) demolish the said building works described under item (i), (ii), (iii), (v), (vii) & (viii) above; and
 - (b) reinstate the parts of the building so affected by the building works under item (i) to (ix) above in accordance with the plans approved by the Building Authority.

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.
4. You are required under the Buildings Ordinance to appoint a Registered General Building Contractor to carry out the works in paragraph 3 above, and an Authorized Person or a Registered Structural Engineer to co-ordinate the required works in paragraph 3 above, who shall:-
 - (a) submit remedial proposals to the Building Authority for approval and obtain consent for commencement of works before commencing such works; and
 - (b) on completion, certify that such works have been carried out in accordance with the provisions of the Buildings Ordinance and regulations made thereunder.
5. You are required to commence the works ordered by me in paragraph 3 above within 60 days and complete such works within 120 days of the date of this order, all to the satisfaction of the Building Authority.

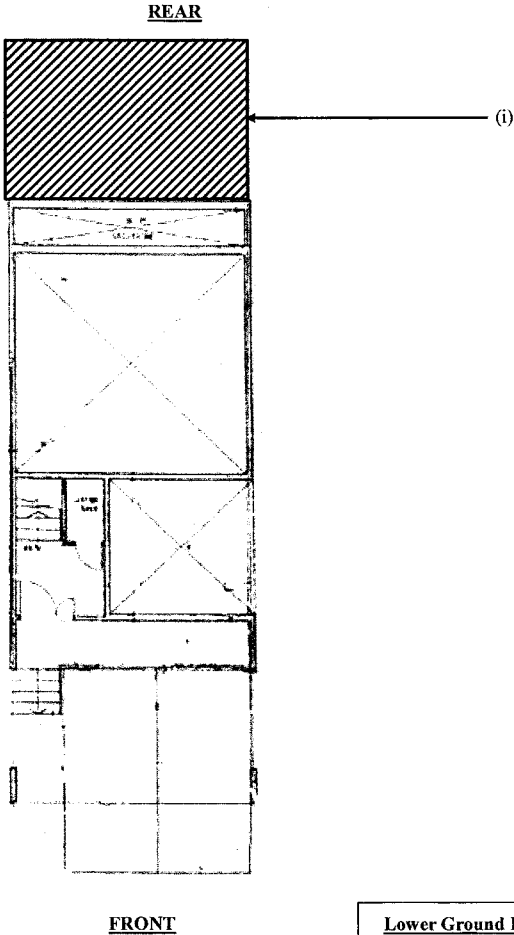

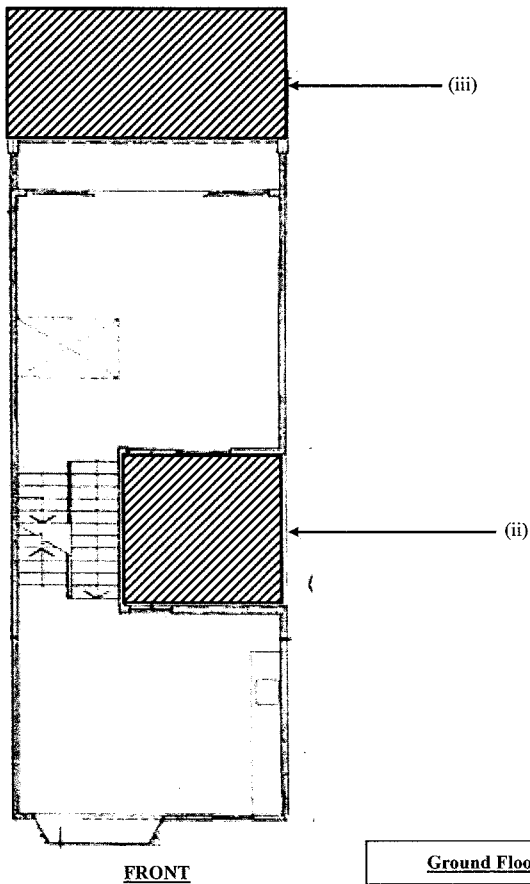

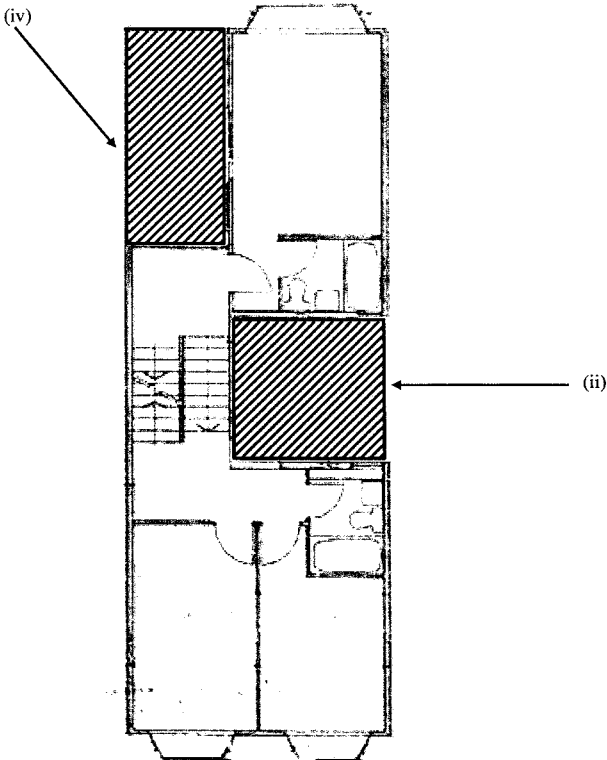

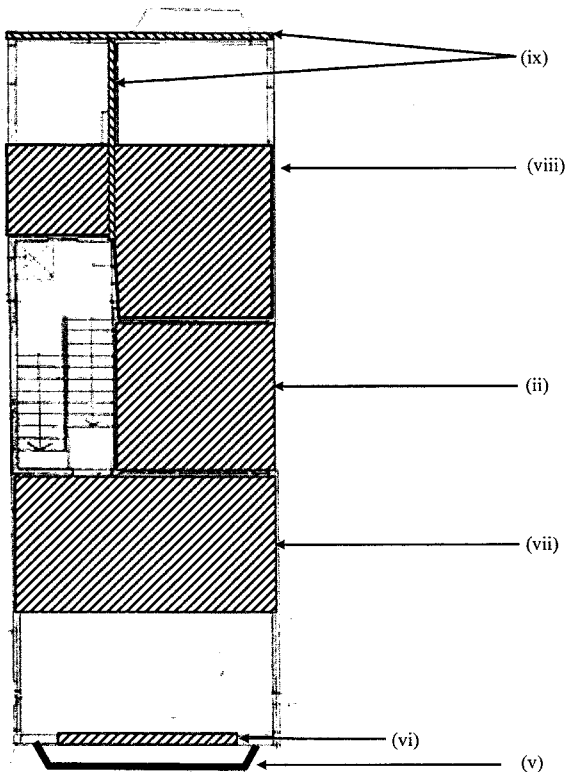
