  - demolish the said building works described under item (i) to (viii) above; and
  - reinstate the parts of the building so affected by the building works under item (i) to (viii) above in accordance with the plans approved by the Building Authority.

Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

- You are required under the Buildings Ordinance to appoint a Registered General Building Contractor to carry out the works in paragraph 3 above, and an Authorized Person or a Registered Structural Engineer to co-ordinate the required works in paragraph 3 above, who shall
  - (a) submit remedial proposals to the Building Authority for approval and obtain consent for commencement of works before commencing such works; and
  - (b) on completion, certify that such works have been carried out in accordance with the provisions of the Buildings Ordinance and regulations made thereunder.
- You are required to commence the works ordered by me in paragraph 3 above within 60 days and complete such works within 120 days of the date of this order, all to the satisfaction of the Building Authority.






