

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DE/2016/08—Term Contract for Inspection, Repair, Overhaul and Testing of Electrical and Mechanical Installations at Various Sewage Treatment Works and Pumping Stations in Sha Tin and Sai Kung (2017–2020)**. The works include the provision of inspection, repair, overhaul and testing of electrical and mechanical installations at various sewage treatment works and pumping stations in Sha Tin and Sai Kung regions for thirty-six (36) months. The works are scheduled to commence in February 2017 for completion in January 2020.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor of North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 6 January 2017. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 6 January 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of the change will be made through the radio.

Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the Category of ‘Mechanical Plant and Equipment Installation (Group II)’ (confirmed), ‘Electrical and Mechanical Installation for Sewage Treatment and Screening Plant’ (confirmed), ‘Industrial Type Electrical Installation’ (confirmed) or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder/one of the members being on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the Category of ‘Mechanical Plant and Equipment Installation (Group II)’ (confirmed), ‘Electrical and Mechanical Installation for Sewage Treatment and Screening Plant’ (confirmed) or ‘Industrial Type Electrical Installation’ (confirmed) who also meet the qualifications and conditions for participation stipulated in the tender documents are invited to tender.
