

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DE/2016/13—Term Contract for Waste Disposal and Minor Civil Engineering Works at Various Sewage Treatment Works and Pumping Stations in the New Territories (2017–2020)**. The works include disposal of wastes and minor civil engineering works at various sewage treatment plants and pumping stations in the New Territories for thirty-six (36) months. The works are scheduled to commence in April 2017 for completion in March 2020.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box located on the ground floor of North Point Government Offices at 333 Java Road, Hong Kong, before 12.00 noon on Friday, 13 January 2017. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 13 January 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Contractors not yet on the List of Approved Contractors for Public Works under the Category of Roads and Drainage in Group B may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by Friday, 30 December 2016 to Chief Engineer/Sewage Treatment 1, Sewage Treatment Division 1, Drainage Services Department at 1st Floor, Administration Building, Sha Tin Sewage Treatment Works, 1 Shui Chong Street, Ma Liu Shui, Sha Tin, New Territories, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
