*Note*—Any person who intends to appear on the hearing of the said Petition must serve on or send by post to the abovenamed solicitors, notice in writing of his intention so to do. The notice must state the name and address of the person, or if a firm, the name and address of the firm, and must be signed by the person or firm, or his or their solicitor (if any), and must be served, or if posted, must be sent by post in sufficient time to reach the abovenamed solicitors not later than 6:00 o'clock in the afternoon on the 10th day of January 2017.
