KWUN TONG LINE EXTENSION

**NOTICE OF ORDER AUTHORIZING
PERMANENT CLOSURE OF A SECTION OF MAN SIU STREET;
PERMANENT ALTERATION OF SECTIONS OF MAN TAI STREET AND
HUNG HOM ROAD; AND TEMPORARY CLOSURE OF SECTIONS OF
MAN SIU STREET, MAN TAI STREET, HUNG HOM ROAD, TAK MAN STREET,
WUHU STREET, WAN HOI STREET, TAK FUNG STREET,
TAK TING STREET AND SHUNG KING STREET; AND TAK ON STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 13 December 2016 (the 'Order'), authorized:—

- (I) the permanent closure of the carriageway widths of the section of Man Siu Street, as delineated and shown in orange on the Plan numbered KTE/G04/0004/8 with effect from 1 January 2017;
- (II) the permanent alteration of sections of Man Tai Street at its junction with Man Siu Street, and sections of Hung Hom Road near Man Tai Street, as delineated and shown in green and pink respectively on the Plan numbered KTE/G04/0004/8 with effect from 1 January 2017; and
- (III) (a) the temporary partial closure of the footpath widths of sections of Man Siu Street, as delineated and shown in dark blue on the Plan numbered KTE/G04/0004/8;
- (b) the temporary partial closure of sections of Man Tai Street at its junction with Man Siu Street, the section of Hung Hom Road between Tak Hong Street and Tak Fung Street, the section of Tak Man Street between Hung Hom Road and Wuhu Street, the section of Wuhu Street between Tak Man Street and Taku Street, the section of Wan Hoi Street between its junction with Tak On Street and a point about 50 metres northeast of the junction, the section of Tak Fung Street between its junction with Tak On Street and a point about 80 metres southwest of the junction, the section of Tak Ting Street between its junction with Tak On Street and a point about 80 metres northeast of the junction, and sections of Shung King Street between Tak Hong Street and Tak On Street, and between Tak On Street and Tak Fung Street, as delineated and shown in yellow, brown, grey, dark green, beige, blue, dark grey and red respectively on the Plan numbered KTE/G04/0004/8; and
- (c) the temporary partial closure of Tak On Street, as delineated and shown in purple on the Plan numbered KTE/G04/0004/8,

during the period from 1 January to 30 June 2017,

for the purposes of or incidental to the railway scheme of the Kwun Tong Line Extension. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
