Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works.

4. You are required to commence the works ordered by me in paragraph 3 above within <u>90</u> days and complete such works within <u>180</u> days of the date of this order, all to the satisfaction of the Building Authority.




