AMENDMENTS TO THE APPROVED CHAI WAN  
OUTLINE ZONING PLAN NO. S/H20/21

Notice is hereby given that, pursuant to the power under section 46 of the Interpretation and General Clauses Ordinance (Chapter 1), the Town Planning Board has substituted the notice under section 5 of the Town Planning Ordinance (Chapter 131) published on 23 September 2016 (publication of the notice in the *Gazette* was made under G.N. 5314) by the following notice:—

AMENDMENTS TO THE APPROVED CHAI WAN  
OUTLINE ZONING PLAN NO. S/H20/21

In the exercise of the power conferred by section 12(1)(b)(ii) of the Town Planning Ordinance (the Ordinance), the Chief Executive in Council (CE in C) on 29 April 2014 referred the approved Chai Wan Outline Zoning Plan No. S/H20/21 to the Town Planning Board (the Board) for amendment.

The Board has made amendments to the Plan. The amendments are set out in the Schedule of Amendments. The description of the area affected by the amendments in the Schedule of Amendments is for general reference only. The exact location of the area affected by the amendments is more specifically shown on the draft Chai Wan Outline Zoning Plan No. S/H20/22.

The draft Chai Wan Outline Zoning Plan No. S/H20/22 showing the amendments is exhibited under section 5 of the Ordinance for public inspection for a period of two months from 18 November 2016 to 18 January 2017 during normal office hours at the following locations:—

- (i) the Secretariat of the Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (ii) the Planning Enquiry Counter, 17th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (iii) the Planning Enquiry Counter, 14th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories;
- (iv) the Hong Kong District Planning Office, 14th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong; and
- (v) the Eastern District Office, Home Affairs Enquiry Centre, Ground Floor, Eastern Law Courts Building, 29 Tai On Street, Sai Wan Ho, Hong Kong.

In accordance with section 6(1) of the Ordinance, any person may make representation to the Board in respect of any of the amendments. The representation should be made in writing to the Secretary, Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong not later than 18 January 2017.

In accordance with section 6(2) of the Ordinance, a representation shall indicate:—

- (a) the particular matter in any of the amendments to which the representation relates;
- (b) the nature of and reasons for the representation; and
- (c) the amendments (if any) proposed to the draft plan.

Any representation made to the Board will be available for public inspection under section 6(4) of the Ordinance until the CE in C has made a decision in respect of the draft plan in question under section 9. Any person who intends to make representation is advised to read the 'Town Planning Board Guidelines on Submission and Publication of Representations, Comments on Representations and Further Representations under the Town Planning Ordinance' (the Guidelines) for details. Statement on Personal Data

The personal data submitted to the Board in any representation will be used by the Secretary of the Board and Government departments for the following purposes:—

- (a) the processing of the representation which includes making available the name of the person making the representation (hereafter known as 'representer') for public inspection when making available the representation for public inspection; and
- (b) facilitating communication between the 'representer' and the Secretary of the Board/Government departments in accordance with the provisions of the Ordinance and the relevant Town Planning Board Guidelines.

MADE BY THE TOWN PLANNING BOARD  
UNDER THE TOWN PLANNING ORDINANCE (Chapter 131)

I. *Amendments to Matters shown on the Plan*

Item A — Rezoning of a site at the junction of Chai Wan Road, Wing Ping Street and San Ha Street from 'Open Space' to 'Residential (Group A)' and stipulation of building height restriction.

Item B — Rezoning of a site at Cape Collinson Road from 'Other Specified Uses' annotated 'Funeral Parlour' to 'Other Specified Uses' annotated 'Columbarium' and stipulation of building height restriction.

II. *Amendments to the Notes of the Plan*

- (a) Incorporation of a new set of Notes for the 'Other Specified Uses' annotated 'Columbarium' zone.
- (b) Incorporation of 'Art Studio (excluding those involving direct provision of services or goods)' as a Column 1 use in the 'Industrial' zone and in Schedule II of the 'Other Specified Uses' annotated 'Business' zone, and corresponding amendment to replace 'Place of Recreation, Sports or Culture' under Column 2 in the same schedules by 'Place of Recreation, Sports or Culture (not elsewhere specified)'.
