

PHARMACY AND POISONS ORDINANCE (Chapter 138)

DIRECTION MADE BY THE DISCIPLINARY COMMITTEE
OF THE PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance, Chapter 138, Laws of Hong Kong ('the Ordinance') to inquire into the conduct of an authorized seller of poisons, namely Shun Hoi International Union Medicine Trading Company Limited at Ground Floor, 93 Ma Tau Wai Road, To Kwa Wan, Kowloon, has conducted an inquiry on 11 November 2016 in accordance with section 16 of the Ordinance.

The said Committee was satisfied after the inquiry that Shun Hoi International Union Medicine Trading Company Limited had been guilty of misconduct in that at the material time, Shun Hoi International Union Medicine Trading Company Limited, an authorized seller of poisons, its two directors, Mr. LUK Shun-hoi and Ms. CHAN Nim-har and its employee, Mr. WONG Siu-cheung, were convicted of the following offences under the Antibiotics Ordinance (Chapter 137, Laws of Hong Kong), on 10 June 2016 at Kowloon City Magistrates' Courts, for which the following penalties were imposed:—

It is further notified that under section 16(2)(b) of the Ordinance, the said Committee directed that the Secretary of the Pharmacy and Poisons Board of Hong Kong should serve a warning letter on Shun Hoi International Union Medicine Trading Company Limited and that its decision in the inquiry should be published in the Government of the Hong Kong Special Administrative Region Gazette with an account of the proceedings.
