## PHARMACY AND POISONS ORDINANCE (Chapter 138)

## DIRECTION MADE BY THE DISCIPLINARY COMMITTEE OF THE PHARMACY AND POISONS BOARD OF HONG KONG

It is hereby notified that a Disciplinary Committee appointed by the Pharmacy and Poisons Board of Hong Kong under section 15 of the Pharmacy and Poisons Ordinance, Chapter 138, Laws of Hong Kong ('the Ordinance') to inquire into the conduct of an authorized seller of poisons, namely Kaiser Global Pharmacy O/B Kaiser Global Pharmacy Co., Limited, at Shop A, Ground Floor, Fat Tseung Building, 290–292 Castle Peak Road, Cheung Sha Wan, Kowloon, has conducted an inquiry on 11 November 2016 in accordance with section 16 of the Ordinance.

The said Committee was satisfied after the inquiry that Kaiser Global Pharmacy O/B Kaiser Global Pharmacy Co., Limited had been guilty of misconduct in that at the material time, Kaiser Global Pharmacy Co., Limited operating Kaiser Global Pharmacy, an authorized seller of poisons, and its employee, Mr. MOK Chung-ho, were convicted of the following offences under the Ordinance and the Trade Descriptions Ordinance, Chapter 362, Laws of Hong Kong on 30 March 2016 at Kwun Tong Magistrates' Courts for which the following penalties were imposed:—

It is further notified that under section 16(2)(b) of the Ordinance, the said Committee directed that Kaiser Global Pharmacy O/B Kaiser Global Pharmacy Co., Limited should be disqualified from being an authorized seller of poisons for a period of 3 days with effect from 24 December 2016. The said Committee added that its direction should be published in the Government of the Hong Kong Special Administrative Region Gazette with an account of the proceedings.
