

**RAILWAYS ORDINANCE (Chapter 519)  
(Notice under section 23)**

**SHATIN TO CENTRAL LINK**

**NOTICE OF ORDER AUTHORIZING  
TEMPORARY CLOSURE OF SECTIONS OF WAN WAH STREET,  
TSZ WAN SHAN ROAD, WAI WAH STREET AND SHEUNG FUNG STREET**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 29 December 2016 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Wan Wah Street between its junction with Tsz Wan Shan Road and a point about 190 metres south of the junction, and the section of Wan Wah Street between a point about 120 metres north of its junction with Yuk Wah Street and a point about 60 metres south of the junction, both delineated and shown in dark green on the Plan numbered SCL/G10/0009/8; and
- (II) the temporary partial closure of the section of Tsz Wan Shan Road between a point about 60 metres southeast of its junction with Ching Fai Street and a point about 190 metres northwest of the junction, the section of Wai Wah Street between its junction with Wan Wah Street and a point about 30 metres east of the junction, and the section of Sheung Fung Street between its junction with Wan Wah Street and a point about 50 metres west of the junction, as delineated and shown in orange, red and purple respectively on the Plan numbered SCL/G10/0009/8,

during the period from 21 January to 31 December 2017 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of the Order and the Plan numbered SCL/G10/0009/8 (the 'Plan') may be inspected by the public free of charge at the following places and during the following hours when those offices are normally open to the public:-

A copy of this notice will be affixed on or near the roads affected by the Order on 6 January 2017.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Housing on 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong so as to reach the Secretary before the expiration of one year from the closure of the relevant part or parts of the roads or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the roads affected by the Order.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
