It is hereby notified that the undertaking in relation to the foreshore and sea-bed described in the Schedule below as mentioned in G.N. 5952 published under section 5 on 21 October 2016 and 28 October 2016 was authorized under section 7 by the Chief Executive on 6 January 2017.

Any person who considers that he has an interest, right or easement in or over such foreshore and sea-bed that will be injuriously affected by the undertaking may deliver a written claim for compensation for the injurious affection to the Director of Lands, 20th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before the expiration of 1 year from the date of publication of this notice in the *Gazette*, stating the sum of money which he is willing to accept in full and final settlement of his claim together with such particulars as he may possess to substantiate the claim.

#### **SCHEDULE**

### Foreshore and sea-bed affected

Approximately 250 square metres of foreshore and sea-bed situated in West Kowloon as delineated and shown edged red on a plan, numbered KM9590, deposited in the Land Registry.

Description of the undertaking and the manner in which the foreshore and sea-bed will be affected by the proposed undertaking

- (i) Construction of a pair of permanent seawater outfalls along a section of an existing seawall in West Kowloon to support District Cooling System at West Kowloon Cultural District. The internal size of each outfall will be about 2 metres wide by 2 metres high at an invert level of about 3.5 metres below Hong Kong Principal Datum.
- (ii) Installation of a pair of temporary seawater outfall pipes (about 600 millimetres internal diameter) at the top of the existing seawall. The temporary seawater outfall pipes will be removed upon completion of the permanent seawater outfalls.
- (iii) Reconstruction of the above section of the existing seawall (about 30 metres long).

#### Personal Information Collection Statement
