PROPOSED PERMANENT CLOSURE OF THE EXISTING PUBLIC TRANSPORT INTERCHANGE AT PAK WAN STREET AND ASSOCIATED WORKS

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths, the existing refuge islands and parts of the existing planters within limit of works area as shown on Plan No. SP14/C/GAZ-01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 1932 published on 4 April 2014 and 11 April 2014. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 2 February 2017 to 1 February 2018, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths, the existing refuge islands and parts of the existing planters to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve conversion of sections of the existing carriageways at Pak Wan Street into temporary footpaths, conversion of sections of the existing footpaths at Pak Wan Street into temporary carriageways, temporary relocation of an existing refuge island and other ancillary works.

Any person entitled to compensation under the Ordinance may serve a written claim upon the Secretary for Transport and Housing, 22nd Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before the expiration of one year from the date of closure.
