The Amendment Plan and amendment scheme were referred to in G.N. 3100 published on 3 June 2016 and 10 June 2016. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 24 January 2017, all public or private rights in, upon, under or over the sections of the existing carriageway and footpaths of Chi Kiang Street fronting Sung On Street to be permanently closed, shall be extinguished.

The works to be carried out in association with this closure mainly involve the permanent closure and demolition of sections of the existing carriageway and footpaths of Chi Kiang Street fronting Sung On Street.
