

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 13/WSD/I6—Mainlaying in Tseung Kwan O (Public Works Programme Item No. 9357WF)**. The works comprise the laying of about 10 kilometres of fresh water mains, connecting the proposed desalination plant and the existing Tseung Kwan O Fresh Water Primary Service Reservoir. The works are scheduled to commence in July 2017 and will take about 42 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in Government Logistic Department Tender Box on the Ground Floor of North Point Government Offices at 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 31 March 2017. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.

Contractors on the List of Approved Contractors for Public Works in Group C (Confirmed) for Waterworks or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Contractors for Public Works in Group C (Confirmed) of Waterworks Category who also meet the qualifications and conditions for participation stipulated in the tender documents are invited to tender.

Contractors not yet on the List of Approved Contractors for Public Works in Group C (Confirmed) of Waterworks Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 1 March 2017 to Chief Engineer/Design, Water Supplies Department, on 46th Floor, Immigration Tower, 7 Gloucester Road, Wan Chai, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
