TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing footpaths within the limit of works area as shown on Plan No. CE58/GAZ/KF90/0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 1513 published on 6 February 2015 and 13 February 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 27 February 2017 to 26 February 2018, all public or private rights in, upon, under or over the sections of the existing footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a lift at the existing footbridge no. KF90 across Lei Yue Mun Road near Tsui Ping Road, the construction of an elevated platform to connect the proposed lift with the existing footbridge, the construction of a staircase to connect the proposed elevated platform and other ancillary works.
