

It is hereby notified that sealed tender in triplicate is invited for the **Provision of Cleansing and Supporting Services to Hong Kong Public Libraries of the Leisure and Cultural Services Department for a period of 36 months from 1 July 2017 to 30 June 2020 (Tender Ref.: LCT 6018/16(S))**.

Late tenders will not be accepted.
