The services scope of each contract comprises setting up of glass container collection network and the associated arrangement in the respective responsible catchment area, provision of glass container collection and processing services, delivering processed glass cullet to designated stockpiling areas and/or arrangement for alternative recycling outlets for recovered glass containers. Each service contract is of 5 years and scheduled to commence in the second half of 2017.

Each tender must be clearly marked with the respective tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor of the North Point Government Offices at 333, Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 21 April 2017. Late tenders will not be accepted.

In the event that tropical cyclone warning signal No. 8 or above or a black rainstorm warning signal is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 21 April 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered or the black rainstorm warning signal has ceased to be in effect.
