Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. CTTD/001289/15/K dated 29 August 2014 and 10 July 2015 respectively is also empowered to make this order which substitutes the previous order.
