The Plan and scheme were referred to in G.N. 1635 published on 13 February 2015 and 18 February 2015. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 19 March 2017 to 18 March 2018, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of two lifts at the existing footbridge no. HF105 across Aberdeen Praya Road near Ocean Court and Jing Hui Garden, the construction of elevated platforms to connect the proposed lifts with the existing footbridge, the construction of a staircase to connect the proposed elevated platform near Jing Hui Garden with the existing footpath and other ancillary works.
