NOTICE OF ORDER AUTHORIZING TEMPORARY CLOSURE OF SECTIONS OF CONVENTION AVENUE AND FENWICK PIER STREET; AND LUNG KING STREET

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Housing (Transport) has, by order made on 20 March 2017 (the 'Order'), authorized:-

- (I) the temporary partial closure of the section of Convention Avenue between its junction with Fenwick Pier Street and a point about 180 metres east of the junction, as delineated and shown in yellow on the Plans numbered SCL/G35/0053/2 and SCL/G36/0053/1;
- (II) the temporary partial closure of the section of Fenwick Pier Street between its junction with Convention Avenue and a point about 230 metres west of the junction, as delineated and shown in green on the Plan numbered SCL/G36/0053/1; and
- (III) the temporary partial closure of Lung King Street, as delineated and shown in red on the Plan numbered SCL/G36/0053/1,

during the period from 8 April 2017 to 7 April 2018 for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the sections of the roads to be affected and the manner in which they will be affected is given in the Schedule below.

Notice is hereby given that further closure of the same part or parts of the roads or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
