Pursuant to that section, the Building Authority who is empowered under section 24(1) of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. <u>UBR/RB07-26/0005/12</u> dated 21st July 2015 is also empowered to make this order which substitutes the previous order.
