It is intended to invite tenders in late 2017 from prequalified tenderers for Contract No. HAB/KTSP/01—Design, Construction and Operation of the Kai Tak Sports Park at Kai Tak, Kowloon City District, Hong Kong. The tenders to be invited will be covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The scope of works of the contract comprises the design, construction and operation of the Kai Tak Sports Park of site area of about 28 hectares in the north apron of the former Hong Kong International Airport in Kai Tak, Kowloon City District. Facilities included in the project comprises a multi-purpose Main Stadium with a spectator capacity of around 5000, a Public Sports Ground with a spectator capacity of around 5000, an Indoor Sports Centre with a multi-purpose main arena with a seating capacity of 10000 and an ancillary sports hall with a seating capacity of 500, retail and dining outlets with gross floor area (GFA) of about 60000 m², a bowling centre with 40 lanes, a health and wellness centre with GFA of about 2500 m², and Public Open Space of more than 8 hectares. The construction floor area is about 390000 m². Subject to funding approval of the Legislative Council Finance Committee of the Hong Kong Special Administrative Region, the contract is scheduled to commence in 2018 for a period of 25 years (including the design, construction and operation period).

Applicants meeting the following requirements:-

- The applicant or at least one joint venture participant/joint venture shareholder/nominated
 first tier sub-contractor has completed at least one building contract with design and build
 arrangements with an original contract sum of not less than HK\$ 1 Billion (adjusted to
 current price) in Hong Kong or any place outside Hong Kong, on or after 1st January
 2007;
- 2. The applicant or at least one joint venture participant/joint venture shareholder/nominated first tier sub-contractor/operations team leader has experience in the operation of at least one stadium with a seating capacity of not less than 20 000 or at least one arena with GFA of not less than 4 000 m², in Hong Kong or any place outside Hong Kong, for a continuous period of at least 3 years on or after 1st January 2007;

and other qualifications and conditions for participation stipulated in the prequalification documents are invited to apply for prequalification.

Joint ventures satisfying the requirements stated in the prequalification documents will be considered.
