

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DC/2017/01—Construction of a dry weather flow interceptor at Cherry Street box culvert (Public Works Programme Item No. 4380DS)**. The works comprise construction of an underground dry weather flow interceptor with automatic penstocks at Cherry Street box culvert; a pumping station; an underground bypass box culvert; about 270 metres of underground twin rising main from the pumping station to an existing sewer at Lin Cheung Road; and ancillary works. The works are scheduled to commence in August 2017 for completion in February 2022.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Logistics Department Tender Box situated on the Ground Floor of the North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Friday, 9 June 2017. Late tenders will not be accepted. If a black rainstorm warning signal or tropical cyclone warning signal No. 8 or above is in effect at any time between 9.00 a.m. and 12.00 noon on Friday, 9 June 2017, the tender closing time will be postponed to 12.00 noon on the first working day after the black rainstorm warning signal has ceased to be in effect or the tropical cyclone warning signal No. 8 is lowered. An announcement of change will be made through the radio.
