

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2896EM16T—Triennial Term Contract for The Maintenance and Repair, Alteration and Additions to Fire Service Installations in Venues in Hong Kong Island and Island (South) for the Government of the HKSAR.** The works shall include maintenance, repair, alterations and additions to the fire service installations at Venues in Hong Kong Island and Island (South) for the Government of the HKSAR. This Contract is scheduled to commence in October 2017 for completion in September 2020.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 4128f, 41st Floor of the Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 9 June 2017. Late tenders will not be accepted.

Selective tendering is adopted. Contractors on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Fire Service Installation (Group II), or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Fire Service Installation (Group II), who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (A) The tenderer shall have completed maintenance and repair contract works for Fire Service installation with a total aggregate contract value of not less than HK\$11.2 million within the 5-year period immediately preceding the tender closing date specified in the Letter of Invitation to Tender regardless of any subsequent extension. In the case of a joint venture, only the lead participant or major shareholder is required to meet this minimum experience requirement; and
- (B) The tenderer or the lead participant/major shareholder of the joint venture must be on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Fire Service Installation (Group II).

Contractors not yet on the List of Approved Suppliers of Materials and Specialist Contractors for Public Works under the category of Fire Service Installation (Group II) may submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list on or before 26 May 2017 to Mr. LAM Kwok-leung, General Engineering Services Division, Electrical and Mechanical Services Department, 6th Floor, 3 Kai Shing Street, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and their application for inclusion is duly approved on or before the tender closing date.
