

TOWN PLANNING ORDINANCE (Chapter 131)

AMENDMENTS TO THE APPROVED FU TEI AU AND SHA LING  
OUTLINE ZONING PLAN NO. S/NE-FTA/14

In the exercise of the power conferred by section 12(1)(b)(ii) of the Town Planning Ordinance (the Ordinance), the Chief Executive in Council (CE in C) on 7 February 2017 referred the approved Fu Tei Au and Sha Ling Outline Zoning Plan (OZP) No. S/NE-FTA/14 to the Town Planning Board (the Board) for amendment.

The Board has made amendments to the Plan. The amendments are set out in the Schedule of Amendments. The descriptions of the areas affected by the amendments in the Schedule of Amendments are for general reference only. The exact locations of the areas affected by the amendments are more specifically shown on the draft Fu Tei Au and Sha Ling OZP No. S/NE-FTA/15.

The draft Fu Tei Au and Sha Ling OZP No. S/NE-FTA/15 showing the amendments is exhibited under section 5 of the Ordinance for public inspection for a period of two months from 7 April 2017 to 7 June 2017 during normal office hours at the following locations:—

- (i) the Secretariat of the Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (ii) the Planning Enquiry Counter, 17th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong;
- (iii) the Planning Enquiry Counter, 14th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories;
- (iv) the Sha Tin, Tai Po and North District Planning Office, 13th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories;
- (v) the North District Office, 3rd Floor, North District Government Offices, 3 Pik Fung Road, Fanling, New Territories;
- (vi) the Ta Kwu Ling District Rural Committee, 198 Ping Che Road, Ta Kwu Ling, New Territories; and
- (vii) the Sheung Shui District Rural Committee, 3 Po Wan Road, Sheung Shui, New Territories.

In accordance with section 6(1) of the Ordinance, any person may make representation to the Board in respect of any of the amendments. The representation should be made in writing to the Secretary, Town Planning Board, 15th Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong not later than 7 June 2017.

In accordance with section 6(2) of the Ordinance, a representation shall indicate:—

- (a) the particular matter in any of the amendments to which the representation relates;
- (b) the nature of and reasons for the representation; and
- (c) the amendments (if any) proposed to the draft plan.

Any representation made to the Board will be available for public inspection under section 6(4) of the Ordinance until the CE in C has made a decision in respect of the draft plan in question under section 9. Any person who intends to make representation is advised to read the 'Town Planning Board Guidelines on Submission and Publication of Representations, Comments on Representations and Further Representations under the Town Planning Ordinance' (the Guidelines) for details. Statement on Personal Data

The personal data submitted to the Board in any representation will be used by the Secretary of the Board and Government departments for the following purposes:—

- (a) the processing of the representation which includes making available the name of the person making the representation (hereafter known as 'representer') for public inspection when making available the representation for public inspection; and
- (b) facilitating communication between the 'representer' and the Secretary of the Board/Government departments in accordance with the provisions of the Ordinance and the relevant Town Planning Board Guidelines.

MADE BY THE TOWN PLANNING BOARD  
UNDER THE TOWN PLANNING ORDINANCE (Chapter 131)**

*I. Amendments to Matters shown on the Plan*

- Item A1 — Incorporation of two pieces of land in the northern part of the Kong Nga Po site from the Man Kam To Outline Zoning Plan (OZP) No. S/NE-MKT/2 into the planning scheme area and rezoning them from 'Undetermined' and 'Green Belt' ('GB') to 'Government, Institution or Community (1)' ('G/IC(1)').
- Item A2 — Incorporation of two pieces of land in the northern part and southern part of the Kong Nga Po site from the Hung Lung Hang OZP No. S/NE-HLH/9 into the planning scheme area and rezoning them from 'GB' to 'G/IC(1)'.
- Item A3 — Rezoning of the central part of the Kong Nga Po site from 'GB' and 'Agriculture' to 'G/IC(1)'.
- Item B — Incorporation of a piece of land zoned 'GB' to the north-west of the Kong Nga Po site from the Man Kam To OZP No. S/NE-MKT/2 into the planning scheme area with no change to its land use zoning.

*II. Amendment to the Notes of Plan*

Revisions to the Schedule of Uses of the 'G/IC' zone to incorporate 'Firing Range (on land designated 'G/IC(1) only')' and 'Helicopter Landing Pad (on land designated 'G/IC(1) only')' as Column 1 uses.
